OFFICIAL RULES

1. PROMOTION DATES

a. The **2024 Carteret Heating & Cooling Fishing Giveaway** (“Promotion”) will begin on November 1, 2024 at 12:00 am ET and end on December 1, 2024 at 11:59 pm ET. The winner will be notified within 15 days of the end of the contest.

2. ELIGIBILITY RESTRICTIONS

a. The Promotion is open to all legal residents of the United States and the District of Columbia (except NY and FL) who are 18 years of age or older at the time of entry and who live in North Carolina.
