

**2025 Carteret Heating & Cooling Dog Days of Summer Giveaway
OFFICIAL RULES**

1. PROMOTION DATES

a. The **2025 Carteret Heating & Cooling Dog Days of Summer Giveaway** (“Promotion”) will begin on July 1, 2025 at 12:00 am ET and end on September 30, 2025 at 11:59 pm ET. The winner will be notified within 15 days of the end of the contest.

2. ELIGIBILITY RESTRICTIONS

a. The Promotion is open to all legal residents of the United States and the District of Columbia (except NY and FL) who are 18 years of age or older at the time of entry and who live in North Carolina. Employees of **Carteret Heating & Cooling and Sound Ace Hardware** (the “Sponsor”), its parent, subsidiary, and affiliated entities, its advertising agencies, participating sponsors/promotional partners and the members of their immediate families (spouse, parents, siblings or children) or households (whether related or not) are ineligible to participate or win. 5. WINNER SELECTION AND NOTIFICATION

d. The winner will be notified by email. Winner(s) (or their parents or legal guardians if under the age of majority) must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of notification attempt or winner will be disqualified and the prize will be forfeited and an alternate winner(s) may be chosen by random drawing. Any attempt by an entrant or any person to deliberately damage any Sponsor web channel or to undermine the legitimate operation of this Promotion may be a violation of criminal and civil laws. Should such an attempt be made, the Sponsor reserves the right to seek full prosecution and/or damages from any such individual to the fullest extent permitted by law. The Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of this provision.
