OFFICIAL RULES**

1. PROMOTION DATES

- a. The 2026 Carteret Heating & Cooling and Sound Ace Hardware & General Store All American Summer Giveaway

("Promotion") will begin on July 28, 2026 at 12:00 am ET and end on August 16, 2026 at 11:59 pm ET. The winner will be notified within 10 days of the end of the contest.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all legal residents who are 18 years of age or older at the time of entry. b. Should such an attempt be made, the Sponsor reserves the right to seek full prosecution and/or damages from any such individual to the fullest extent permitted by law. The Sponsor's failure to enforce
